On Thursday, April 28, 2022 the Circuit 18 Juvenile Justice Advisory Board (JJAB), met at the Brevard County Sheriff's Office – North Precinct in Titusville. The meeting was called to order by Secretary Mike Scully at 1:35 pm.

II. Special Presentation –Brevard CARES Mobile Response Team (MRT)

Tommy Shoriak from Brevard CARES spoke about the Brevard CARES Mobile Response Team (MRT). The MRT provides free 24 hour on-demand, on site crisis intervention services to Brevard County children and families in crisis. Services are provided by a multi-disciplinary team of licensed and masters leveled behavioral health professionals. The primary goal of MRT is deescalate crisis situations, stabilize families, and connect families with appropriate community based resources.

The MRT is available 24 hours a day, 7 days a week, and has a targeted response time of 60 minutes or less. MRT serves youth or young adults ages 25 and under. For more information contact Brevard CARES at (321) 213-0315.
