A. Public Works presentation on the Project Management Software

The Committee and Public Works discussed major projects underway, the process for right-of-way acquisition, stormwater management and reuse, and ADA and multi-modal requirements for new and improved projects.

The Committee complimented the process improvement and the budget savings associated with implementing this software in-house.
