Claudine Mickle introduced the item. This matter was previously brought before the Board at the December 2023 meeting where the Board heard testimony from complainant Lisa Hogreve. The Board had motioned to table the request reasonable time for the parties to come to agreement and for staff confirm any other complaint history of Timothy Sanders.

Claudine Mickle confirmed there had been four other complaint cases filed against Mr. Sanders in the past and provided the details to the Board.

Mrs. Hogreve was present. She stated she had emailed communication to Mr. Sander's legal representative on December 21, 2023 and had not received a reply.

The Board requested in the future that staff provide the complaint history at the time of the Request for Show Cause Hearing.

David Baker, Attorney for Timothy Sanders addressed the Board. He stated he had not been able to reply due to office closure for the holidays and not being able to consult with Mr. Sanders due to other pressing business. Mr. Baker requested a 30 day delay of the Request for Show Cause Hearing to allow time for communication between his client and Mrs. Hogreve.

The Board discussed the amount in the judgment and how a contractor reasonably would pay such an amount rather than risk their license. Further, Mr. Baker was told that since the Show Cause Hearing would be in about a
